# SP Negócios supports new waste management process

In April, SP Negócios has signed an agreement with the Municipal Authority of Urban Cleaning (Amlurb) to support the new Decree 58.701/2019, which announces the strengthening of inspections in large waste generators, establishments which produce more than 200 liters of waste per day.

SP Negócios provides assistance to promote the decree and communicate with the market, by presenting the project to the companies involved in the private waste removal and to the large waste generators, which have a deadline - early July – regulate its waste collection with AMLURB.

As a next step, the agency will support the construction of a communication plan to inform these establishments about the law.

# Concession of São Paulo's Municipal Market and Kinjo Yamato Market

In April, the City of São Paulo launched the public consultation for the concession of the City's Municipal Market – Mercadão - and the Kinjo Yamato Market, both located in the central region of the city. The concession intends to promote the restoring, operation and maintenance of the assets for a period of 25 years.

The bidding modality is an international competition and the criterion of judgment is the one of greater fixed grant to the Municipality, being the minimum value of US\$ 7.1 million. The annual variable grant will be calculated considering the gross annual revenue of the concessionaire and the expected total cost is R\$ 87 million.

Currently, Mercadão holds 290 boxes, offering 350 tons of food per day. Together with the Kinjo Yamato Market, the concession area amounts to 27 thousand square meters. Mercadão is one of the main tourist attractions of São Paulo City.

### **Real Estate Opportunities**

Among the assets that integrate the Municipal Privatization Plan is the sale of properties owned by São Paulo City Government. On May 1st, a property located at Avenida Professor Alceu Maynard Araújo, south area of the capital, was launched. The winner of the bid will be the one that presents the highest bid, with a minimum value of US\$ 13 milion. All individuals or legal entities that meet the conditions established in the pertinent legislation are able to participate.

The proposals will be received on June 3rd, from 9 a.m. to 10:30 a.m., in Sala Olido, located at Avenida São João, 473, ground floor. The opening session will take place the same day, starting at 10:30 am.
